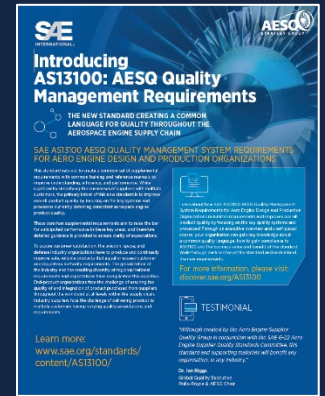
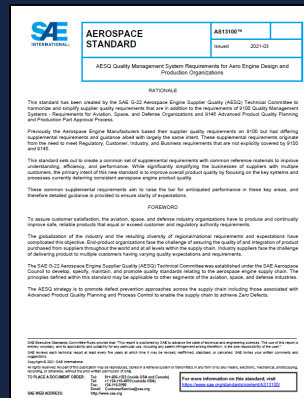
AESQ welcomed new Members Cincinnati Thermal Spray, Consolidated Precision Products (CPP) and Meggitt PLC.

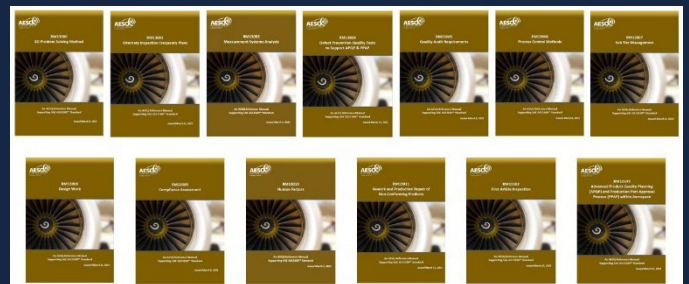

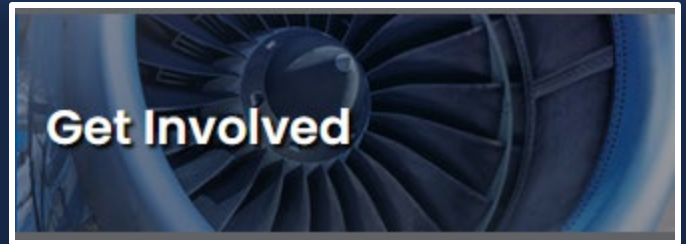
